- Q. How long have you been in the "Ristradrut" organization?
- A. I have been there for about 6 months.
- Q. Who was the organizer of your circle?
- A. It was then Kalik Mikhail who is in Odessa and Isak Tulchinskiy who ran away to Bessarabia.
- Q. Who of your schoolmates was together with you in the circle?
- A. Together with me in the circle were Volodia Wainer, Benzion Franz, losif Stekolschik.
- Q. What is now your job to organize the circles?
- A. I now make no work because there is no work and I am not a Zionist any more, and I am just an individual.
- Q. Whom do you know among the old Zionists working in Tiraspol?
- A. I know Shwartsman, Waingaus, and Kizer(?) who escaped.
- Q. What is your feeling now towards Zionism?
- A. Indifferent. I have no further statement to do and I sign thereto.
