This report will be briefer than usual as I have been standing in for our indisposed President, Alex Schlesinger, for only part of the year.

We have continued uninterrupted with our main function, that of providing services in the Synagogue every Sabbath & on all major festivals.

We have continued to contribute to Bristol Chabad to ensure the services of the Chabad Rabbi to assist with our services.

Social functions have been held in the Synagogue hall, we continue to offer light hospitality after Sabbath services.

By merging the assets of the Epstein Trust with those of Bristol Hebrew Congregation we are in an improved position financially, allowing us to carry out necessary improvements to the synagogue house & thereby increase the rental income.

We have granted an option to DFE Developments to sell the unused land behind the synagogue, this at the end of long and involved discussions. This was done with the agreement of the congregation and there is a minimum price quoted for the land & a share in any excess above the minimum.

Our Cheder (Sunday school) is once again in operation with the involvement of some of the younger parents.

Following our recent AGM our Council now has a younger age profile giving us grounds for optimism for our long term future as a community.
