Chair of Council

This is my second Trustees report as the Chair of our Synagogue. The year since the last report has not been without its highs and lows.

My attention has been taken up with several situations which took time to resolve and I thank members of Council in 2017 and in 2018 for their support, diligence and patience in their appointed roles.

Our religious activities are of course one of the most important parts of any synagogue, together with Teaching and Pastoral Care. In this regard, thanks are due to our Rabbi, Larry Becker but also our Senior Wardens (Melvin Pedro (2017) and Andrew Lewis (2018) and their team of lay readers and Wardens. Andrew is also in charge of Adult Education. Care is a co-operation between the Rabbi and the Care Group headed by Reeva Godson.

As mentioned last year, Jocelyn Shepherd retired as the Head Teacher from the Religion School and was replaced by Bryony Bathie. The Religion school is overseen by Karen Watch and Bryony is assisted by previous pupils who have celebrated their Bnei Mitzvah and our thanks go to them as well.

Our Religion School has been causing some concern due to falling numbers and parents who wish their children to have a Bar or Bat Mitzvah need to contact us so we can plan for their tuition for this and other areas of Judaism such as festivals and Shabbat.

Council is kept in line with reports, agendas, minutes and dates by Angela Jacobs, our Hon. Secretary who also provides members with letters informing them of the date of the Yahrzeit for a loved one. Angela also collates the Security rota for the small group of members who provide security for you not only on the High Holy Days but throughout the year, and our thanks are due to them all. We can always use more help!!!

English Heritage

The synagogue has benefited in the past from a significant donation from English Heritage and the National Lottery towards the refurbishment of the main building.

The synagogue building has Grade 2* listed status. These are high quality buildings, mostly unaltered, and often with an interior of special interest.

A listed building

may not be demolished, extended, or altered without special permission from the local planning authority, which typi-



cally consults the relevant central government agency.

We at Sukkat Shalom take pride in our building and as and when we have funds we are making sure that it is well maintained.

We are aware that some of the brickwork needs replacing and we will see that this is done over time. Our new Treasurer, Jeff Lustig, aided by the Finance Committee has continued to review contracts from companies supplying us with Insurance, Broadband, Gas and Electricity saving the Synagogue substantial expenditure.

Of our paid staff, as opposed to volunteers, Rabbi Larry continues to remain heavily involved in inter -faith matters across Redbridge. He also acts as a liaison between the Rabbinic Assembly and the JJBS and sits on the Beit Din (the Jewish court of law). Frank Godson continues to be an invaluable asset to both the Synagogue and in assisting me and Council. There is very little he does not know about our members or our Synagogue and we remain one of the only Synagogues whose records are completely up to date with the JJBS and Movement for Reform Judaism.

We have acquired the services of Omkar Jutley who provides assistance to the Gardening team and has just taken up all our cleaning, again saving us money but giving us the assurance of a job well done.

The maintenance of the buildings is at times an ongoing battle, but our Chair of House Jocelyn Shepherd is very diligent on repairs etc. when required.

This year we became the first Synagogue to host a series of

lectures under the auspices of the Leo Baeck College's Lehrhaus programme. Over a 5-week period around 10 members attended a series of talks on the Great Commentators, the lives and times of the rabbinical biblical commentators. The talks were given by Rabbi Mark Solomon and were enjoyed by all. Further such lectures are expected to be organised. Thanks to both Susan and Tony Leach for their idea for this programme and the planning of it to bring it to fruition.

The Tikkun Olam Group under Rachel Savage continues to meet and propose issues for the Community. Mitzvah Day both last year and this year will be on their agenda along with other social issues.

The other members of your Council, Elaine Laurie, Joel Ilson and Samantha Lustig should also be thanked for their service.

Between all the members of council we have members of the Finance Committee, Wardens, Lay Readers, Publicity and other areas. That is not to say that only members of Council are to be thanked. Others, not on Council are also owed thanks for the various roles they undertake which enable the Sukkat Shalom Reform Synagogue to be a community with an increasing membership, be financially sound and well represented in the wider Jewish Community.

Finally, the outstanding bank loans on the building was paid off this year so we as a community now own the buildings outright. Work will commence on considering the best way to secure members rights with the possible incorporation of the Synagogue as a company.

I will ensure that you are all kept involved in our thoughts and plans.

The Synagogue Grounds

The shul gardens survived a very cold Winter and a very wet early Spring to emerge in full bloom with the newly planted bulbs in the car park flower bed looking especially good.

It looks like it's going to be a hot dry summer so any casualties will be replaced in the Autumn by drought resistant plants and hopefully will survive any adverse weather conditions.

Our gardener Brian Jones has done a sterling job thinning out the overgrown shrubbery adjacent to Victory Road. He has removed the four large Rosemary bushes from the front of the Shul. These were planted by the site developers when Wanstead Hospital was converted into flats. They had become infested by Rosemary Beetles and had grown far too large for the position they were in. Lookout for new planting in the Autumn which will be more appropriate for this area.

We now have the assistance of Omkar Jutley who, as part of his duties, will water the plants during any dry period. I continue to oversee the gardens and completed three pruning sessions in the Spring.

I am looking forward to another year of colour without any climatic catastrophes!

The new Woodland Cemetery at Cheshunt is now being used on a



regular basis. An extended car park has been built and plans are being considered for a Gathering Hall where small events can be held after a stone setting at the Woodland. When this is built it is envisaged that the JJBS staff will move from Sukkat Shalom to the cemetery where offices are also being built.

It is possible to pay in advance for a Woodland Burial and the current cost remains at £1600. Please speak to our Administrator for further details on this or on any matter relating to the JJBS and your membership.

There is also the availability of Mixed Faith burial at Cheshunt for Associate members of SSRS. Again, please speak to the Administrator if you are interested.

Finally, within the JJBS, this Synagogue has one of the best track records for its membership lists and the involvement and information of its members. This is due to our Administrator Frank Godson to whom on your behalf and in my role as Governor, I offer our thanks and gratitude.

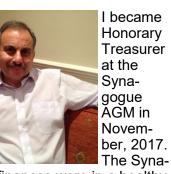

As a Finance Committee we have met regularly through the year.

The JJBS Jewish Joint Burial Society 1 Victory Road Wanstead London E11 1UL

The Jewish Joint Burial Society (JJBS) provides this community



with burial, or cremation. Burials take place at its cemeteries in Cheshunt in either the main Cemetery or the Woodland Cemetery. Cremations take place at Hainault or Golders Green. Their offices are rented from SSRS and are on our site in Wanstead. Our thanks are offered to the staff who work there for their help and assistance throughout the year when they are the only people on the premises.

A copy of a Funeral Guidelines Booklet has been produced for our own use. This booklet is given to all new members. All new members are required to sign a document to say that they have received a copy of the booklet. We are well represented at the JJBS with Frank Godson and Jocelyn Shepherd as two of the Elected Governors (Frank is also a past Chairman) and Steve Wynne as a Governor. Frank and Steve sit on the Risk & Investment Sub-Committee of the Society and Jocelyn Chairs the Grants Committee. Frank also sits on this committee.

The level of funerals including non-member funerals carried out by the JJBS continues to grow beyond expectations. For those who are unaware the money generated from the non -member funerals is donated to worthy causes by the JJBS via the Grants committee.

The synagogue continues to hold monies on behalf of some of its members to cover certain fees due to the JJBS on their death. These monies are also supported by a surcharge on all Late Entry Payments (LEP) made by members who join the Synagogue aged over 50 and who have not been a member of the JJBS before. promoting good relationships with other faith groups).

The Board has continued to represent the Jewish community over the past year. In the political realm, the challenged anti-semitism in political life, particularly in the Labour Party. It also engaged with other political parties on issues of concern to the community. The Board worked with burial societies to challenge the discriminatory practices of the Inner North London coroner and ensure that Jewish people in that area can be buried swiftly, in accordance with Jewish law. The Board continued to present its Jewish Living Exhibition at venues around the country and arrange Jewish way of life tours for school children. The tours include visits to synagogues, a kosher lunch, and exposure to other aspects of the Jewish community.

The Board commissioned a report into Jewish births and deaths to understand the demographics of the community. This report, along with previous reports and Jewish education and synagogue membership, are available on the Board's website as a resource for the whole community to enable planning and strategic development. The Board published a curriculum guide to the Judaism section of the new GCSE available to purchase in hard and soft copies and strives to represent the diverse beliefs in the community. Another Board publication was a guide for courts about Jewish family

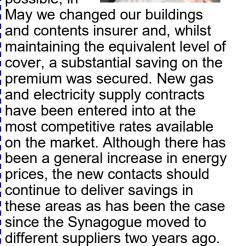
life and customs, launched in association with Supreme Court President Lade Hale.

This year, Rachel Savage continued to serve as a member of the Board's Constitution Committee and the Finance and Organisation Division. She served as returning officer for the election of the Board's Honorary Officers for the 2018-21 term. The Honorary Officer team elected for 2018-21 is the most gender balanced in the Board's history (comprising three women and two men) and represents most strands of belief within the community (with Deputies from Reform, Liberal, United Synagogue and Sephardi backgrounds). The new president, Marie van der Zyl, is the first Reform woman to head the Board. The synagogue contributed approximately £2300 to the Board this year. The synagogue makes a contribution from the subscriptions of most members and invites members to make contributions over and above this.

When doing so, we receive excellent data on the Synagogue's financial position compiled by our Administrator, Frank Godson, This data enables us to monitor income and expenditure, subscription payments and arrears as well as costs related to maintenance contracts and projects. Frank provides further invaluable support to the management of the Synagogue's finances through signing up new members, collecting subscription arrears, dealing with our banking and managing the funeral fund.

Ever mindful of the need to ensure our outgoings are carefully scrutinised and savings obtained wherever possible, in



All contracts for works have been entered into in compliance with the Synagogue's procurement arrangements.

The Chair of House, Jocelyn Shepherd, has been scrupulous in ensuring value for money and quality of workmanship in all of these contracts. Her diligence in this area has been greatly appreciated.

Subscription income has remained broadly at last year's level and arrears are always kept low.

A milestone in the Synagogue's history took place in March when we paid the final instalment on the loan taken out from NatWest Bank in 2000. This loan was to part finance the major renovation of the Synagogue building that took place at that time. The rest was financed by a very substantial grant from the English Heritage Lottery Fund.

The prudent management of the Synagogue's finances meant that I was able to recommend to the Council that there be no increase in membership subscription fees for the 2018/19 financial year. The Council agreed to this recommendation. Whilst it would be nice to say that no increases in fees will be a regular occurrence going forward, the reality is that this will not be possible. Because of inflation and other pressures, it will usually be necessary for there to be a modest increase in membership subscription fees on an annual basis. We will, of course, do our best to manage outgoings as carefully as possible so as to limit any increases to a minimum.

Membership subscription fees make up the greatest part of the Synagogue's income. After subscription fees, the next most significant element of the Synagogue's income is the tax reclaim we are able to make where members have signed Gift Aid declarations.

For members who are taxpayers, if they have signed a Gift Aid declaration, the Synagogue is able to reclaim from HMRC a sum equal to 25% of their membership subscription fee and any donations they may have made during the year. This is worth around £20,000 to the Synagogue each year.

I would encourage any member who is a taxpayer but has not yet provided the Synagogue with a signed Gift Aid declaration, to please do so. It is an excellent way of giving financial support to the Synagogue with the cost being borne by HMRC.

By way of illustration of the importance of Gift Aid declarations, I would mention the new Sefer Torah purchased by the Synagogue during the past year. The Synagogue was able to do this with the help of a very substantial donation by one of our members, who is now sadly deceased.

However, not only did we have the benefit of that donation to put to the cost of the new Sefer Torah, but also the Gift Aid on the donation which we were able to reclaim from HMRC.

Another source of income to the Synagogue is rent/licence fees. The Jewish Joint Burial Society occupies offices in the Cheder Block. They are expected to be moving out of these offices to new offices at the cemetery in the near future. It is hoped that we will be able to find another suitable tenant to occupy the office space so that the Synagogue does not lose this important income.

Further income is received from the Han Cherry Pilates Classes that take place at the Synagogue two evenings a week.

I am satisfied that the Synagogue has maintained sufficient unrestricted funds to ensure an appropriate level of general financial reserves.

As my predecessor concluded in her report last year, the Synagogue Council and the Finance Committee strive to keep expenditure and any increases

Related Charities - CST

(Community Security Trust)

The CST is proud of Britain's diverse and vibrant Jewish community, and seeks to protect its many achievements from the external threats of bigotry, anti-Semitism and terrorism. CST provides physical security, training and advice for the protection of British Jews. CST assists victims of anti-Semitism and monitors anti-Semitic activities and incidents. CST represents British Jewry to Police, Government and media on anti-Semitism and security.

CST believes that the fight against anti-Semitism and terrorism is an integral part of safeguarding our wider democratic British society against extremism and hatred.

Sukkat Shalom has received a considerable grant from the CST in order to upgrade its CCTV system & gates. We are extremely grateful to them and their staff for this work.



Related Charities - Board of Deputies



The Board of Deputies of British Jews is an organisation that represents the British Jewish community

by promoting and defending the religious and civil liberties of Jews. Based on its size, Sukkat Shalom is entitled to elect two Deputies to the Board, however for both the 2015-18 term and 2018-21 term, only one candidate stood for election. Rachel Savage served for the 2015-18 term and stepped down as a Deputy at the end of May 2018. Joel Ilson was elected as Deputy for the 2018-21 term and took up office at the beginning of June 2018.

The Board operates through four divisions: finance and organisation (concerned with the governance and finance of the Board itself), communities and education (promoting cross-communal activities including education and social care), international (interfacing with Jewish communities around the world and representatives of foreign governments in the UK) and defence and interfaith relations (defending religious practices, standing up to anti-Semitism and

Security

In the 6 months to the end of June 2018 the number of anti -Semitic incidents in the UK fell by 8% compared to the same period in 2017. To put that into context, over the UK there were 727 incidents reported to the CST. You can understand why the security of our members whilst on our premises continues to remain a high priority for your Council.

The small group who voluntarily stand and provide security are all Synagogue members and are to be commended for their assistance in providing you, the Community, with a level of cover that enables members who attend services and other activities without any concerns and all without costing the Synagogue a penny.

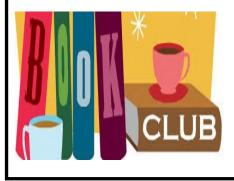

Senior Wardens Report



I write this report as Senior Warden for the second time, taking over from Melvin Pedro during the year in No-

vember. On behalf of the whole congregation, I wish to express our deepest thanks and gratitude to Melvin for the last seven years' service as Senior Warden. Seriously.. Melvin, is a tough act to follow!

We have continued to share many festive occasions with our ECAMPS neighbours. In July, we hosted the Erev Tisha B'Av service. We shared a lovely Tu B'Shevat Seder, and Shavuot Tikkun Leyl study sessions at SWESRS. Yom HaShoah was hosted by ELELS, which included a moving performance of a new children's play by Lenna Rosenberg, former Head teacher at Clore Tikva. There was also a joint Friday Night Jazz Service at SWESRS that was very enjoyable.

The High Holidays (2017) ran smoothly, and it is always nice to see the synagogue so busy. Thanks to everyone who participated in

one way or another, and a special thank you to Melvin and Tracy Pedro for hosting the Tashlich Tea. Congratulations go to our Chatan Torah, Tony Leach, and Chatan Berieshit, Joel Ilson, (2017) who performed so well.

In December (2017), we celebrated Chanukah with a very successful Jazz Chavurah, held in our synagogue and shared with SWESRS. A very large turnout enjoyed a wonderful Jazz Service and a lovely meal in a festive atmosphere. If you missed it, don't worry, we will be repeating it again this year!

Purim this year was a bit of a non-event, as the snow made it difficult for people to attend. The Communal Pesach Seder however went very well, and I understand that the new caterers were good. . Certain parts of the database are regularly given with updates to some members of Council and specific members of the synagogue outside of Council. A number of members of the synagogue and Council are given permission to handle synagogue data on their home computers.

Council members who leave Council are asked to delete all sensitive membership data from their computers, including phone numbers, email addresses etc. Some of the data that we hold is divulged to the Jewish Joint Burial Society, CST and the Reform Movement. We ask all members on joining to sign a declaration allowing us to do this.

Plans for the Future of the Building and significant works carried out during this year.

Apart from all of the general maintenance issues, appliance testing etc. there has been no major work carried out in the buildings this year. We have carried out some minor works namely a new water heater in the kitchen of the shul and a purchase of some new chairs and a book trolley. We are currently in dispute with the Water Board over a bill for a leak in the system. We hope that this will be resolved soon.

For next year we need to fix the flooring to front of Bimah. This part of the floor was pulled up during the heating upgrade.

We plan to paint the exposed pipes to the central heating system in the synagogue We also feel that the time has come to repaint the railings which encircle the building.

The Foyer ceiling will be painted in August and a cupboard for the CST communicators will be built in the Cheder Block.

Also during August some of the heating pipework between the synagogue and the Cheder Block will be replaced.

During the next Financial year we will commission a survey on our electrical system. This has not be done for several years and is a request from our new insurers.

Other than this we have no **major** projects to consider during 2018/19.

If you feel that there is anything that we are neglecting in the buildings please let us know.

Insurance

The synagogue currently insures the buildings and its contents with Blue Fin Financial Services Limited. We changed our insurers this year in order to reduce the cost. The Brokers are Make it Cheaper Financial services limited

We also have employers liability cover as well as insurance for personal accidents.

The Council has clarified the situation re insurance cover for those carrying out security duties and have confirmation that we are covered for these activities.

During the year the synagogue made no claims to the insurance company

An Insurance certificate is displayed on our notice boards.

Synagogue History

The synagogue and its buildings have a considerable History some of which is included in a small booklet which is available on request.

We will also conduct lectures based on the History of the Wanstead Orphanage Site, on request from outside organisations.

New General Data Protection Rules

During the year we embarked on producing a policy in order to comply with the new data protection rules which came into effect in May 2018.

We have produced a general document which has been circulated to all members giving our stance on what we do with members personal data.

We have also issued a general consent form and we ask that you all complete it in the stamped address envelope provided and return it to the Administrator.

So far we have receive back about 37% of the forms which is very poor considering that all our members have to do is tick some boxes and put it into an already stamped addressed envelope and post it back to the synagogue.

If you have not already sent your form back please do so as quickly as possible..

The synagogue does maintain a substantial database with information on our members. This database is managed by Frank Godson. Thanks go to Tracy Pedro, Karen Watch, and Jocelyn Shepherd for organising everything. We have celebrated three Bnei Mitzvah this year, and we wish Thomas St. George, Lily Saunders, and Claudia Potter, and their families, a big Mazeltov! We also say Mazeltov to Kasey Miller and family who celebrated a baby blessing. Also to those couples that were married under the auspices of the synagogue during the year.

During the year we have purchased the new Reform Shiva Books. We have also been blessed with a huge donation towards the cost of a new Sefer Torah. There are plans for a big celebration, completing and bringing in our new scroll in November 2018.

Finally, I am indebted to our Rabbi, Lay Readers and Wardens, whose help and hard work make everything possible.

Trustees Report

This Trustees Report is produced for the benefit of the Charity Commissioners, our members and any prospective new members.

The Trustees Report is designed to give a complete overview of the synagogue in general and the synagogue's various activities and services which are carried out throughout the year. It also gives details of our employees' activities, information about risk, plans for the future, information on some standard documents and details of our involvement with several other charities. This Report is finalised on the 30th June each year even though it is posted to members in October.

The content of this Trustees Report reflects synagogue business up to the end of June 30th 2018. All new members receive a copy of this Report as do the Charity Commissioners.

Mixed Faith Activities

The synagogue, Rabbi Becker & Mitzi Kalinsky in particular participate in a number of ways with all of the mixed faith groups in the area. We also regularly advertise their events in our Shema, on our website and from the Bimah on Shabbat mornings. We also offer up the building for events and meetings free of charge.

Adult Education Report

I am pleased to report on a successful year of Adult Education at Sukkat Shalom. Thanks to the sterling efforts of Tony Leach, we were privileged to be the first synagogue to host a new initiative from the Leo Baeck College, namely, Lehrhaus on the Road. As the name implies, this is a way to bring learning out of the college and take it to the people. In May we hosted a five session course entitled The Great Commentators, brought to us by the excellent Rabbi Mark Sol-



omon. It is very much hoped that we will have more Lehrhaus on the Road in the coming year.

Earlier in the year, Rabbi Larry Tabick brought to us an excellent series of 7 classes on basic Kabbalah. Rabbi Larry is considered to be Reform Judaism's leading exponent of Kabbalah, and I would very much like to see him return next year with some more advanced learning.

The Tuesday Text Study Class has continued in between these other courses, when time has allowed.

They will next resume after the High Holidays 2018.

Tallit & Kippot



All males entering the synagogue must have their heads covered and all Jewish males over 13 should wear tallit where appropriate.

Females may wear Tallit if they wish and will be required to wear tallit if they carry a Torah Scroll.

The synagogue has a stock of kippot and tallitot in the fover for the use of visitors.

Communications Policy

The synagogue communicates with its members through regular mailings, the Shema (our newsletter), the website, our Facebook page and fairly regular announcements via e mail. The synagogue answer phone also takes messages which are collected daily.

Please note that we do not have an office which is manned on a daily basis. If you wish to speak to somebody please leave a message on the answerphone or email.

Mobile Phones

The use of mobile phones for calls or texting is prohibited in the synagogue on Shabbat and Festivals. Should you need to carry your mobile phone into the synagogue you must switch it off or have it on silent.

You must leave the synagogue building before answering a call if it is on silent or vibrate.



Lettings

The synagogue has a policy of hiring out the building to the community at large for a small fee. This is in order to ensure that this valuable asset which has been supported by the National Lottery and English Heritage is accessible to the public in general. Any person or group of people can apply to the Administrator for such use and depending on the type of use an agreement can be reached on a let.

Currently we have a Pilates group which meets regularly in the synagogue

Photography & Video Shabbat

Photographs or Videos are not to be taken during services or Kiddush on Shabbat. Photographs and Videos can be taken outside of the synagogue building after a service. Photographs of the Bar or Bat Mitzvah should be taken in the synagogue at the rehearsal.

Festivals

The above applies to the following Festivals:- Simchat Torah, Rosh Hashanah, Yom Kippur, 1st and last days of Pesach, Sukkot and Shavuot. Photographs or Videos can be taken on Purim, Chanukah, or Tu B'Shevat

Weddings

We allow photographs and video in the synagogue at all weddings. The photographer or videographer must be unobtrusive, must not block the view of the attendees and must position all equipment such that it does not pose a danger to those attending. Photographers and videographers are not allowed into the Bedeken area. Photographs and videoing of the actual signing of the Marriage register is not permitted. Photographs and video can be taken once it is complete.

Close Circuit Television Policy

The synagogue has installed a CCTV system throughout the grounds of the synagogue site.

The system is monitored from within the building via a screen and the 9 cameras mounted on the outside of the main building and 1 within the building. Within the building there is a recording device which records all movements via the cameras onto a hard drive.

The purpose of the system is to help secure the building from vandalism and burglary whilst it is unoccupied and to monitor the movement of visitors. It is also used to help admit congregants to the building during services and events. Data that has been recorded will be used for legal purposes if a crime has been committed on the site. A router has been installed in order to allow the CST, Jocelyn Shepherd & Frank Godson, the Administrator, to monitor the site over 24 hours or as required from off site and home.

During this year we installed new signage in the grounds

The Synagogue's Designated and Restricted Funds

The synagogue currently has a number of Restricted and Designated Funds as shown in our Annual Accounts. They are as follows:-

Funeral Fund *Restricted* This Fund contains all of those monies given to us by members for the purpose of paying off their JJBS Late Entry Payments (LEP). It also provides a surplus to cover the risk of any defaulters.

We encourage all of our members in this category to deposit monies with the synagogue over time in order to fix the payment for all time with the JJBS. We also regularly update all members with a liability to the LEP, who deposit money into this Fund, as well as those who are liable for an LEP and who do not make a contribution. All LEP due to the JJBS have to be recovered from the member on joining the community, over time, by regular payments, on death or before a tombstone is consecrated.

It is clearly better to settle this debt prior to death in order to avoid complications at the time of a funeral. If you receive a statement from the synagogue and you have chosen not to pay over the liability you must pass this information on to your next of kin. The Late Entry Payment rate will increase from January 2019.

The LEP increases as costs rise in regard to the running of the cemeteries.

Scroll Fund Designated

We are still looking at commissioning a new Ark curtain during 2018/19.

We have recently purchased a new Torah Scroll which was written in Israel. The bulk of the cost was met by the Late Bob & Rosalyn Bowman and It will be completed on Sunday the 18th

November where a celebration in the synagogue will be held. Members will be asked if they wish



to assist in its completion by making a small donation to this Fund. This fund will remain open for donations in order to purchase a breast plate and Rimmonim.

Rabbi's Discretionary Fund

Restricted

The Council of the synagogue decided to set up this Fund for the sole use of the Rabbi.

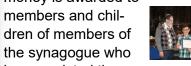


The rules for this Fund are as per the document posted on the website. This Fund is administered by the Rabbi and the Treasurer.

General Donations

We are always looking for members and friends of the community to donate to these Funds and indeed start new ones. Should you wish to make a donation please approach any Council member or the Administrator and he will explain how you can



go about forwarding the money. Once again we thank everybody who has made a donation to the synagogue in the last financial year.

Vulnerable Adults Policy

Sukkat Shalom Reform Synagogue is committed to ensuring that vulnerable people who use our services are not abused and that working practices minimise the risk of such abuse.

All Staff, Volunteers, Trustees & Council Members of Sukkat Shalom Reform Synagogue have a duty to identify abuse and report it. Vulnerable adults are people who are over 18 years of age and are getting or may need help and services to live in the community.

If you or your children wish to be included in any photographs which are used on the website, on Facebook, in our Trustees Report or in the Shema etc. you have to complete the data consent form. Givig us permission.

If you have not completed your consent form or have lost it please speak to the synagogue Administrator who will send you a new one

Yahrzeits

Members are invited to offer the dates of the death of loved ones to the Administrator who sees that a list is kept on the bimah in the synagogue.

Each week on the anniversary of the death the loved one is remembered. Also our Honorary Secretary Angela Jacobs keeps a list of the dates and sends a letter to the member each year in order to remind them. We also send a card and a letter of condolences to all families when there is a death.

Risk - Child Protection

The synagogue has a policy on Child Protection and it was put into place during June 2008. The Child Protection Officer. Tracy Pedro, is also responsible for all of our DBS checks. All new checks were carried out this year.



Angela Jacobs Honorary Secretary and significant titled positions within the synagogue. There is always regular reference at Council meetings to our current financial position and there is always regular monitoring of any reductions in membership income which is our main source of revenue.

Our membership was fairly stable this year. Increases in membership help to reduce the risk of any deficit in our finances. However we have a large number of older members so the number of deaths is increasing this has a significant effect on our growth.

The synagogue regularly updates the insurance policy it has on the buildings etc. We have very comprehensive cover..

We have a number of members suitably qualified in first aid. We have some first aiders who can administer CPR to anybody on site if they required it. Should you not want CPR administered to you, if required, you need to register this with the Synagogue Administrator. Some of our members are also CST trained and as such help with the general security of the building and its members. When Trustees and Council members leave office they are asked to destroy all data that they have of our members on their computers unless they are given specific authority to keep it.

The latter would only occur if they were performing a role within the community that required its use.

Also we require that all paper documentation is returned to the synagogue, handed to a successor in office or destroyed when a person leaves office. All archived data is now stored inside a locked cupboard inside the synagogue. Computer data is backed up regularly and stored in the archive cupboard. The cupboard has restricted access.

All members are reminded that they MUST inform the Administrator of any changes to the information that they provided when they joined. This includes: phone numbers, addresses, email addresses, changes in family arrangements, marriages, divorces, new births etc.

Risk - General

The Trustees (Council members) are responsible for the management of the risks faced by the charity. The Trustees continue to monitor areas of risk within the synagogue.

A Fire Risk document is in place as is a Health and Safety document. A Fire Risk Assessment was carried out during the year and all was in order. The synagogue makes a series of announcements before any major service or function. These relate to means of escape, parking etc.

The electrical appliances are checked each year as are the fire extinguishers. Currently the main financial risk to the synagogue is a decrease in membership with a subsequent loss of income.

A further risk is our liability to the Late Entry Payments (LEP) due to the JJBS. This particular risk is mitigated by collecting regular payments from some members plus a premium on payments. The current value of our General Funds exceeds our liabilities apart from the liability to the JJBS LEP. These payments are dealt with on a regular basis by the Administrator who regularly tries to encourage members to forward their liability to the JJBS thus freezing the amount for all time.

Our finances are reviewed regularly by the Finance Committee and the Treasurers monitor each other. We conduct our finances using internet banking and we leave it to the Treasurers to monitor each other in this regard. The Administrator produces regular financial updates for Council members and views the bank statements.

Arrears in subscriptions are monitored regularly by the Administrator and kept to a minimum. Serious cases of arrears result in deletion, of membership of the synagogue, surcharges and loss of burial rights.

The synagogue continues to be sensitive to the financial circumstances of its members and takes steps to relieve hardship (in relationship to subscriptions) where it is considered to be possible.

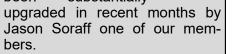

Honorary Life President



The title of Honorary Life President can be bestowed on a member of the synagogue who has shown considerable commitment to its existence and who has dedicated many years of service to its cause.

The title confers no special powers to the recipient and in the main is ceremonial. The Honorary Life President is entitled to attend all Council and Honorary Officers meetings and receive agendas for the same but cannot vote.

During this financial year our Honorary Life President Frank Godson attended most of the Council meetings, all RAC and Finance meetings as our Administrator.

Custodial Trustees of the synagogue

The Synagogue has 2 Custodial Trustees. These Trustees were appointed in 1999. They are:-

Their joint responsibility is for the property of the synagogue which is the site at Victory Road Wanstead.

They are also responsible for health and safety matters and compliance with local authority planning regulations.

The Custodial Trustees have a right to attend all Council meetings and meetings of the Honorary Officers but cannot vote. The current Custodial Trustees have waived their right to receive minutes of Council meetings.

None of the Custodial Trustees takes an active role in the community. Now that our loans are repaid to the bank the Council will address the current situation and recommend changes.

Burial or Cremation

The synagogue provides for its Full members and its Associate Members with burial rights to be buried at the Western Cemetery, Bullsmoor Ride, Cheshunt.

Maintenance of the burial site is handled by the Western Charitable Foundation on behalf of the Jewish Joint Burial Society.

There are sufficient plots to bury at Cheshunt for at least the next 50 years. Alternatively the synagogue can provide a cremation



for members at Hainault or Golders Green crematoriums.

The Jewish Joint Burial Society whose offices are based at the synagogue, are now providing mixed faith burial and woodland burial at Cheshunt. Members of SSRS will be able to use these woodland facilities at an additional cost.

It is planned to start building a new assembly area, refreshment room and offices at the new Woodland Cemetery.

Property & Investments

The synagogue has no significant investments apart from the property at 1. Victory Road Wanstead and a small financial surplus.

The market value of the buildings and land are now considered to be in excess of $\pounds 256,500.00.$

The buildings are insured for reinstatement at a value of £2,900,000.

The bank loan in regard to the purchase of the buildings has now been repaid.

Objects and activities of the Charity (Sukkat Shalom Reform Synagogue)

The objects of the Charity are the provision of Jewish religious services and cultural, educational, social, burial and cremation facilities for Jewish members of the synagogue and their dependents (under the age of 21 yeas old).

The synagogue is based in the UK and has most of its members living in the UK . Non Jews can attend all of these services. Non Jews who have signed up to Associate Membership with burial will be afforded burial and cremation facilities along side our Jewish Members in a special section of the JJBS Woodland Cemetery.

The synagogue also exists for such other charitable purposes which accord with the principles of Reform Judaism or as the Council of the synagogue may from time to time determine. To this end we invite children to our building from local schools, scout groups etc. in order that they can understand a little more about Judaism.

We also allow some charities to hold events in the building at no cost to the charity concerned.

Structure of Membership

Operating procedures exist in the form of a booklet entitled Codes of Practice and Areas of Responsibility.

These procedures are updated regularly. The synagogue has several classes of membership: Full Membership, variations on Full Membership, Associate Membership and Honorary Membership and Associate Membership with burial rights.

The synagogue charges all members and some Associate Members for Burial a per-capita sum, set each year by the Council, which includes the cost of funerals offered by the Jewish Joint Burial Society and fees to the Movement for Reform Judaism. Monies are also collected and sent to the Board of Deputies of British Jews. The synagogue charges some Associate members a per-capita sum, set each year set by the Council, which excludes any voting rights and the cost of a funeral or a cremation.

Synagogue Constitution



The Sukkat Shalom Reform Synagogue, (SSRS), is a registered charity governed by its Constitution &

Laws.

The synagogue was founded in January 1981 as the Epping Forest & District Reform Synagogue. It later changed its name to Buckhurst Hill Reform Synagogue and when we moved to Wanstead we became Sukkat Shalom Reform Synagogue. Our Charity Number is 283615.

The Charity Commissioners are notified of all Special General Meetings and changes to our Constitution. An update on all Trustees (Council Members) is sent to the Commissioners every year by our Honorary Secretary Angela Jacobs (See above)

A copy of the Constitution is available to any member who wishes to receive it and a copy is posted on our website. Please contact the Synagogue Administrator if you would like a hard copy.

Elected Trustees of the synagogue

The Synagogue elected 14 Trustees (Council Members) in November 2017.

Each Full Member of the synagogue has the right to vote in a new Council in November of each year. Associate Members do not have a vote.

Elections are held annually with each Elected Trustee (Council Member) retiring and being eligible for re election for up to a maximum of 7 continuous years of service.

Documents for each AGM are sent out in October of each year.

After serving a continuous 7 years on Council, Council members must have at least 1 year off and cannot be co-opted onto Council during that following year.



The synagogue promotes the Jewish Museum to its members

Elected Trustees Governance and Management of the Charity

All Trustees (Council Members) retire at the AGM in November of each year and a new Council of Trustees is elected at the AGM. The Trustees (Council Members) generally meet 11 times a year (usually on the first Tuesday of each month with the exception of August). They meet in order to act as a "Council" and in order to administer the synagogue (Charity). Should a Council member not attend at least 50% of the Council meetings they will not be eligible to stand for a position on Council the following There are also subvear. committees covering Religious Activities, Education & Finance.

The Council when meeting make all of the strategic and financial decisions on behalf of the synagogue. The Chair of Council together with the Honorary Secretary, Rabbi and Administrator oversee the day to day operations of the synagogue. All other significant decisions are made and ratified by the Council. There are informal procedures adopted for the induction and training of new Trustees (Council members). secondary school and Higher Educational sessions.

He has worked with the Newham SACRE group who visited the synagogue, as a group, this year.

General

The Rabbi acts as the face of the synagogue to the wider general community. He has also been active in local schools both visiting various schools and hosting visits from schools to the synagogue. As well as schools we had a group of Beaver Scouts visit this year.

He conducts all of our High Holyday services apart from 2nd day Rosh Hashanah, and any service where there is a Bar or Bat Mitzvah or other special occasion. He oversees and participates in all aspects of education. He supervises all of our Associate Members who are undergoing Conversion.

He attends all Council meetings, liaises with various members of Council and the Administrator.

He is involved in Care in the community and conducts all weddings for our members.

He also conducts funerals and stone settings.

During his recent Sabbatical the Rabbi continued to officiate at key lifecycle events and reacted to a number of emergency pastoral care situations.
