# DIRECTORS REPORT

#### 1. ACTIVITIES

The directors consider that these activities will remain unchanged in the future.

#### 2. TRANSFER TO/FROM RESERVES

The unrestricted funds surplus for the period of  $\pounds 10,540$  (2000: surplus  $\pounds 2,007$ ) has increased unrestricted reserves carried forward at 31 March 2001 to  $\pounds 17,632$ . Of this, 14,978 was from a bequest. Without this, unrestricted reserves would have increased by  $\pounds 562$  and the Retirement Fund of  $\pounds 5000$  would not have been created.

#### 3. STATEMENT OF DIRECTORS RESPONSIBILITIES

The directors are required to prepare the financial statements which give a true and fair view of the state of the affairs of the company and of the income and expenditure of the company for that period. In preparing those financial statements, the directors are required to:

- Select suitable accounting policies and then apply them consistently;
- Make judgements and estimates that are reasonable and prudent;

- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the group will continue in operation.
