# The Movement for Reform Judaism

## Trustees' Report

The Trustees (who are also Directors of the charity for the purposes of the Companies Act) present their Annual Report together with the audited Financial Statements of the Movement for Reform Judaism (the Company) for the year ended 31 December 2017.

The Financial Statements comply with the, the Companies Act 2006, the Memorandum and Articles of Association and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (FRS102) (effective 1 January 2015).

The Company is a registered charity (number 1139806), (a company limited by guarantee number 07431950), and was incorporated on 8 November 2010.

### Objectives

The objectives of the Movement are to promote and foster Reform Judaism and to promote any charitable purpose calculated to further the welfare of the Jewish people in the UK in Israel or elsewhere in the world.

### Mission

The mission of the Movement is to enable the growth of a vibrant Reform Judaism, inspiring individuals and communities with Reform values and traditions underpinned by the core values of; creating inclusive, egalitarian communities, valuing difference, bringing holiness into the world by seeking meaning in our lives and a just society for all and treasuring the autonomy of the individual, Jewish tradition and the insights of the wider world.

### Aims

- To promote the interpretation of Reform Jewish teaching and practice in relation to contemporary life.
- To promote and co-ordinate the education and religious instruction of Jews.
- To promote and co-ordinate the spiritual life and general welfare of Jewish youth and encourage and co-ordinate youth organisations among Constituents.
- To promote and assist in the establishment and nurturing of Reform congregations of Jews.
- To assist in the exploration of, or initiation of, other forms of Jewish religious community.
- To promote the Leo Baeck College, and/or other institutions, for the study of Progressive Judaism and the training of rabbis, teachers, staff and voluntary leaders.
- To promote the Reform Beit Din to whom the Movement shall refer (*inter alia*) all questions relating to the Jewish status of members and prospective members of Constituents and Associate Congregations.

- To promote the Assembly of Reform Rabbis and Cantors UK to which the Movement shall refer for guidance on matters relating to the practice of Judaism.
- To publish and/or revise prayer books, liturgical writings and literature on subjects of Jewish interest.
- To promote burial and cremation schemes for Constituents and Associate Congregations.
- To promote and nurture Jewish cultural and welfare activities.
- To participate in the work of the wider Jewish community.
- To foster greater understanding among Jews.
- To foster greater understanding between Jews and non-Jews.

The Trustees confirm that they referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives each year.

The charity's affairs are governed by its Memorandum and Articles of Association which allow for any activities covered by the charity's objectives with no specific restrictions. The liability of the members in the event of the Company being wound up is limited to a sum not exceeding £10.

## Governance

The Trustees of the charity are also the Directors of the Company for the purpose of company law and any reference to Trustees is therefore also to Directors, collectively known as the Board. Those who served during the year were:-

Prior to 2016, Members of the Board were elected each year. At the 2016 AGM the Articles of Association were changed and Trustees now retire in rotation at the end of their 3-year term and are eligible for re-election for one further term. Honorary Officers can serve for 3 consecutive terms. At each AGM, one-third of the directors or the number nearest to one-third, must retire from office. Each new Board member is provided with an induction pack and is introduced to the work of the Movement by other Board members and the senior Movement staff.

The Board is responsible for the overall management and control of the charity and meets at least four times a year. The work of implementing the policies and plans agreed by the Board is carried out by the lay leaders and the staff team.

There is one Sub-Committee of the Board and Council, which is the Rabbis and Cantors Remunerations Working Party.

### **Pay Policy for Senior Staff**

The directors consider that the board of directors, who are the Trust's trustees, and senior management are responsible for directing, controlling, running and operating the Trust on a day to day basis. All directors give of their time freely and no director received remuneration in the year. Details of directors' expenses and related party transactions are disclosed in note 12 to the accounts.

The pay of the senior staff is reviewed annually, the directors benchmark against pay levels in other similar charities.

### **Reserves Policy and Risk Management**

The Trustees have considered the risks faced by the charity and have taken appropriate steps to address the related issues. Significant risks to income mainly arise from our dependence on fundraising from individuals and the ability of our communities to pay their Assessment Fee. Internal risks are reduced by the implementation of procedures for authorisation of all transactions and projects.

The reserves policy is set to ensure that total unrestricted funds (including designated funds) should exceed the value of tangible fixed assets by £500K. These actual free reserves at 31 December 2017 were £750K above this figure. The Trustees are of the opinion that net assets held are sufficient to meet the charity's financial obligations.

Attention has also been focussed on non-financial risks arising from fire, health and disaster recover. These risks are managed by ensuring accreditation is up to date, having robust policies and procedures in place, and regular awareness training for staff working in these operational areas.

### **Statement of Trustees' Responsibilities**

The Trustees listed on page 4 are responsible for preparing the Trustees' Report and the Financial Statements in accordance with applicable law and United Kingdom Accounting Standards. (United Kingdom Generally Accepted Accounting Practice).

Company Law requires the Trustees to prepare Financial Statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources including the income and expenditure of the charitable company for that period. In preparing these Financial Statements the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- observe the methods and principles in the Charity's Statement of Recommended Practice (SORP);

- state whether applicable UK Accounting Standards have been followed subject to any material departures and explained in the financial statements;
- prepare the financial statements on a 'going concern' basis unless it is inappropriate to presume that the charitable company will continue in operation.

The Trustees are responsible for keeping accounting records which disclose, with reasonable accuracy at any time, the financial position of the charitable company and which enables them to ensure that the Financial Statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charitable company's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

### **Investment Powers and Policy**

The funds of the Movement not required for immediate application shall be invested in such manner as the Board shall from time to time determine. The Treasurer maintains control over all the funds of the Movement.

### **Related Charities**

The Movement for Reform Judaism is an association of 42 Reform congregations throughout the United Kingdom. There are also two other connected charities which are not under the control of the Movement for Reform Judaism. Details of material transactions with these charities are shown in Note 14 to the financial statements.

### **Statement as to Disclosure to our Auditors**

At the time when this Trustees' Report is approved, each Trustee has confirmed that;

- so far as they are aware, there is no relevant audit information of which the charitable company's auditors are unaware, and
- they have taken all the steps that ought to have been taken as a Trustee in order to be aware of any information needed by the charitable company's auditors in connection with preparing their report and to establish that the charitable company's auditors are aware of that information.

### **Auditors**

Nyman Libson Paul was re-appointed as auditor at the Annual General Meeting held on 25 June 2017.

In preparing this report, the Trustees have taken advantage of the small companies exemptions provided by section 415a of the Companies Act 2006.

- **Developing Reform Jewish communities across the country** by identifying areas for growth and expansion, supporting and nurturing new communities and new kinds of communities.



# Key Highlights 2017

• **Reform Judaism is a community of communities**, a multiplier for each congregation, creating and delivering Reform Judaism in all its diversity, underpinning growth and well-being and devolving best practice across all our communities for their and our future together.



• **Shirei Chagigah, our biennial music conference**, took place in July, with four days of workshops, concerts and prayer hosted by Radlett Reform Synagogue and Finchley Reform Synagogue and attended by people from five countries; a perfect example of Reform Judaism and communities working together.



• **Northern Chagigah, our residential weekend for northern communities** was an uplifting gathering of 120 people from 11 out of the 13 communities in the region. To quote Sherry Ashworth from Manchester, "Reform Judaism in Scotland and the north of England is on an upswing – we are growing in numbers, enthusiasm, learning and commitment".



• **2017 was a year of renewal and innovation** with some exciting key appointments with a particular focus on working with young people, students and young adults.



• **Josh Martin was appointed as Informal Education Director**, taking responsibility for RSY-Netzer and Jeneration, our young people's Mental Health and Wellbeing Team, as well as helping Reform communities to develop their informal education work for young people.

• **We have deepened our capacity to work with young people with mental health challenges** through the appointment of Mark Greenfield, who joins Sharon Daniels as part of our young people's Mental Health and Wellbeing team. The expansion of this team to form a unique and nationally trend setting endeavour has been funded by the generosity of a single donor and responds to the needs of our communities and our desire to provide a safe and inclusive environment for participants on our programmes for young people.

• **Chaplain Rabbi Daniel Lichman has joined us** and together with Rabbi Leah Jordan from Liberal Judaism, they are supporting our students around the country as chaplains to the Alliance for Progressive Judaism.

• **Maya Skaarbrevik began her important work as Jeneration Fieldworker** working with Jewish students on campus to provide

Progressive-led Shabbat dinners, social events, student training, residential weekends and trips abroad, and that important warm feeling of community. Jeneration and the Alliance Chaplaincy are already working closely together to ensure that our students are supported and represented on campus by a strong Reform voice.

- **Our work with young adults beyond university continues** with the appointment of Yael Roberts as Reform Judaism's Young Adults Community Organiser providing inspirational learning and programming for young adults across the country.

- **2017 saw the ordination of six remarkable and exceptional new rabbis for Reform** communities from Leo Baeck College. Our partnership with the college – the heart of the intellectual

and spiritual life of the Progressive Jewish community – is a key part of our work.

- **Over 300 people of all ages celebrated 70 years of Reform youth** movements at the Sternberg Centre in September.

- **Rabbi Janner-Klausner, Senior Rabbi to Reform Judaism, and our community rabbis across the country** represent a strong voice for the Movement and our values in wider society.

- **The public profile of Reform Judaism flourishes** with expanding media coverage. Increasingly, the Jewish voice in broadcast media is a positive and engaging Reform voice.

- **2017 saw tea parties and telethons reaching out to our synagogue members as part of our Communities that Care Initiative.** Communities are responding well and have reported that these events have even helped to shape care provision.

- **2017 ended with planning underway for a** conference on Combatting Loneliness and Isolation in 2018 looking at practical ways to combat loneliness and isolation, and Chagigah – our biennial weekend away in June celebrating Reform Judaism and being part of something bigger. Chagigah will see the launch our newest Initiative: Financial Sustainability. This will focus on developing and co-creating new approaches learning from different experiences in the UK and around the world.

## The Movement for Reform Judaism Strategic Priorities and Future Plans 2019-2021

Reform Judaism continues to be responsive to daily demands and aspire for growth as a national movement, in our membership and communities. Through close relationship building we have seen the wealth of leaders and initiatives that exist within our movement, which can complement each other to build people-focused communities. We have experienced the passion that many of our members have for different areas of their Judaism, and heard how this love can be developed.



By building regional networks we have seen how strong Reform Judaism can be when our communities and members are all working together and we understand the need to expand this model to the whole of Reform Judaism. Our youth movement has grown and continues to develop strong Jewish identities, and we will build on this success to ensure even more of our young members share these positive experiences. Finally we have heard the pride of our members when they see Reform Judaism fighting for social justice, and seen that we can and should be leading for change in our society.

As a result of closely listening to and learning from each of our communities, we have therefore identified five areas where the 2019-2022 strategy should focus. These are:

- **Co-creation with Communities**

Co-creation means working together in partnership to develop communities, framing the work that we do together. This is a bespoke approach to community building that ensures sustainability, invests in future leaders, and enables communities to deepen and increase engagement. Co-creation sees relationships as a key value, prioritising the building of relationships as a way to make an impact.



- **Loving Judaism**

Loving Judaism fosters inspired and engaged Reform Jews using values from the Shema, “and you shall love” - “*v’ahavta*”. We will be further empowered in Jewish practice in our homes, daily lives, and congregations; enhancing inspirational *tefillah* (prayer), continually evolving music, and high quality *chinuch* (learning) in partnership with our clergy and communities.

- **Reform Judaism as a National Movement**

As a strong national movement we need shared values and common goals. Reform Judaism, communities, and clergy will work collaboratively to develop a Reform Covenant which articulates these.



- **From Youth to Adulthood**

The journey of Jewish life from youth to adulthood should develop meaningful and lasting relationships, strengthening the sense of joy in community and in their Jewish identity. We will expand the range of opportunities for engagement for young people. Being led by young adults to provide together what they need to grow communities in which they will flourish.

- **National Leader on Social Issues**

We will strive to be a national leader in issues of British society which reflect the social justice priorities of our members and in which we can have demonstrable impact. *Tikkun Olam* (repairing the world) is an essential part of Reform Judaism’s values, to lead by example so that we can influence wider British society. This ensures Reform Judaism actualises its values and ensures we are continually relevant and inspiring to our members.



- **Co-creation – Embedding the Principles of Relational Judaism**

- ☆ 8-12 communities will develop their chosen projects based around their own unique challenges, partnering with Reform Judaism along their journey.
- ☆ 10-15 leaders from amongst the 150 leaders trained since Chagigah 2016, will participate in the national leadership of RJ
- ☆ Develop the Money for Values: Re-Thinking Synagogues' Finance initiative, launched at Chagigah 2018, with 2-3 communities joining per year, learning to understand the ties between relationships, engagement, and financial contribution
- ☆ Assembly of Reform Rabbis and Cantors UK to participate in the Clergy Training Initiative launched in January 2018



- **Loving Judaism – Fostering Inspired and Engaged Reform Jews**

- ☆ Judaism On The Go/Way - "*U'valechtacha ba'derech*"
  - To have a fully functioning Reform Judaism app - that strengthens our members capacity to practice Judaism and also is a conduit into Reform Judaism for those not yet engaged.
- ☆ With all your heart - "*B'chol l'vavecha*".
  - A core group of clergy, communities and RJ will undertake 2 years of learning resulting in the Tefillah Initiative launching at Chagigah 2020.
  - A team of communities will develop intentional, purposeful, engaging prayer, using tefillah as a tool for community growth and engagement.
  - With all your soul - "*U'v'chol nafshecha*" - Together with communities develop a strategy to promote the use of music in Reform Judaism in order to enrich all areas of communal life, especially *tefillah*.
- ☆ With all your might "*U'v'chol me'odecha*"
  - Subscribers to 'Reform Judaism In 1000 words' and Eits Chinuch increased by 25%.
  - Online resources for educators updated and added to regularly with each section being revisited at least annually.
  - Increased range of online resources and platforms bringing increased traffic to the relevant sections of the website.



- **Reform Judaism as a National Movement – Strengthening our National Community**

- ☆ Together we will develop a national covenant/charter which:
  - defines our shared values and purpose,
  - creates agreed standards of professional practices,
  - sets out mutual expectations of key components of Reform Judaism whilst recognising their autonomy,
  - and respects the spectrum of religious practice within our community.



- **From Youth to Adulthood – Developing Meaningful and Lasting Relationships**

- ☆ Higher number of senior leaders in RSY-Netzer applying for roles on events.
- ☆ Increased retention at key stages in RSY-Netzer journey – year 9, year 13.
- ☆ Develop and run at least one alternative model of national involvement leading to a higher percentage of our members engaging in national events.
- ☆ Continuing to work with communities to ensure that the national journey is reflected in, and reflective of, the provision within communities.
- ☆ Reform students leading in Reform and cross-communal Jewish life on at least 5 campuses in the UK.
- ☆ Develop cohorts of young adult leaders who embrace Reform Jewish values.
- ☆ Increased percentage of *vatikim* (alumni) declare an interest in ongoing communal involvement.





- **National Leader in Social Issues – Responding to the Social Justice Priorities of Our Members**

- ✧ We will drive a campaign engaging a significant number of communities and members to make a national impact. This campaign will be selected through listening to our members and understanding their passions.
- ✧ Together we will identify local leaders to build national and local teams that will champion our campaigns.
- ✧ To identify additional resource required to lead on this work, and fundraise and procure resources in order to achieve this.

## The Movement for Reform Judaism Review of Financial Position

### 2017 Accounts

The Financial Statements have been prepared in accordance with the Statement of Recommended Practice (SORP), 'Accounting and Reporting by Charities': Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective January 2015).

The total incoming resources amounted to £4,181k for the year. This is mainly due to the increase in event and tour income and transfers from provisions/accruals to designated funds for bad debts recovered and a sinking fund for a share of the costs of major building works at the Sternberg Centre.

Charitable expenditure during the year amounted to £3,788k. The increase in expenses is largely due to the higher number of events and tours in the year.

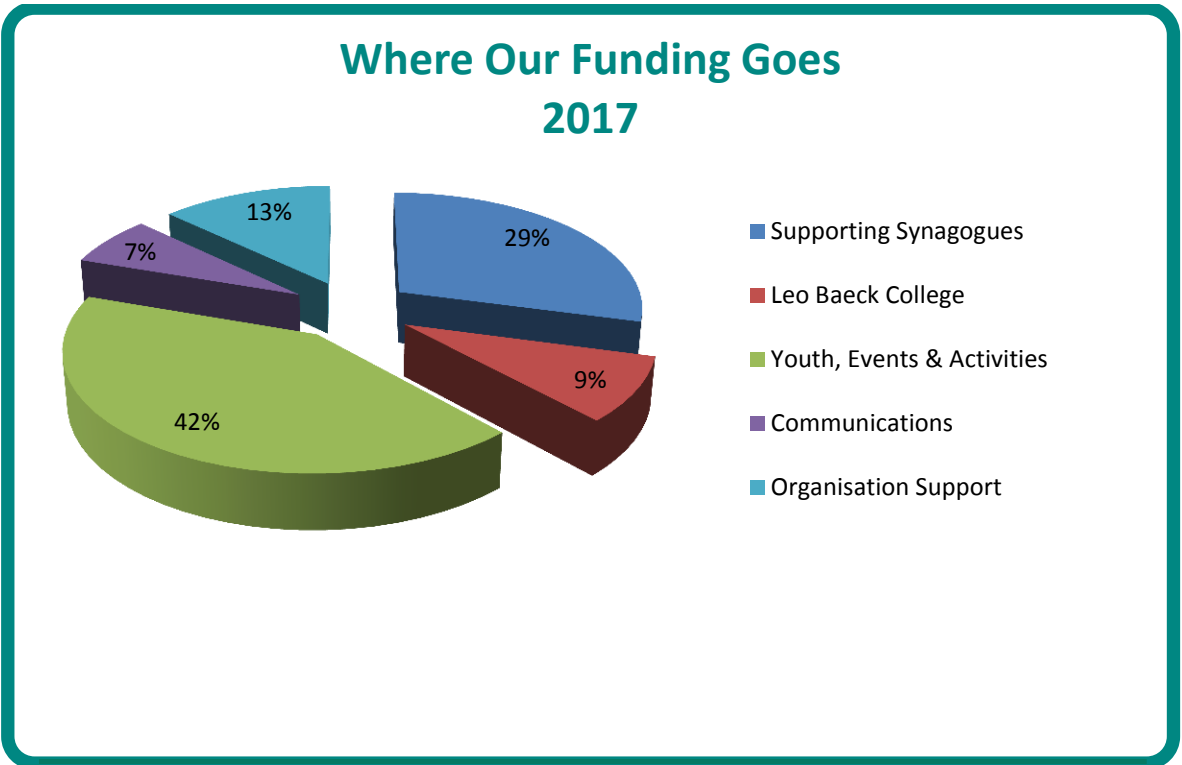
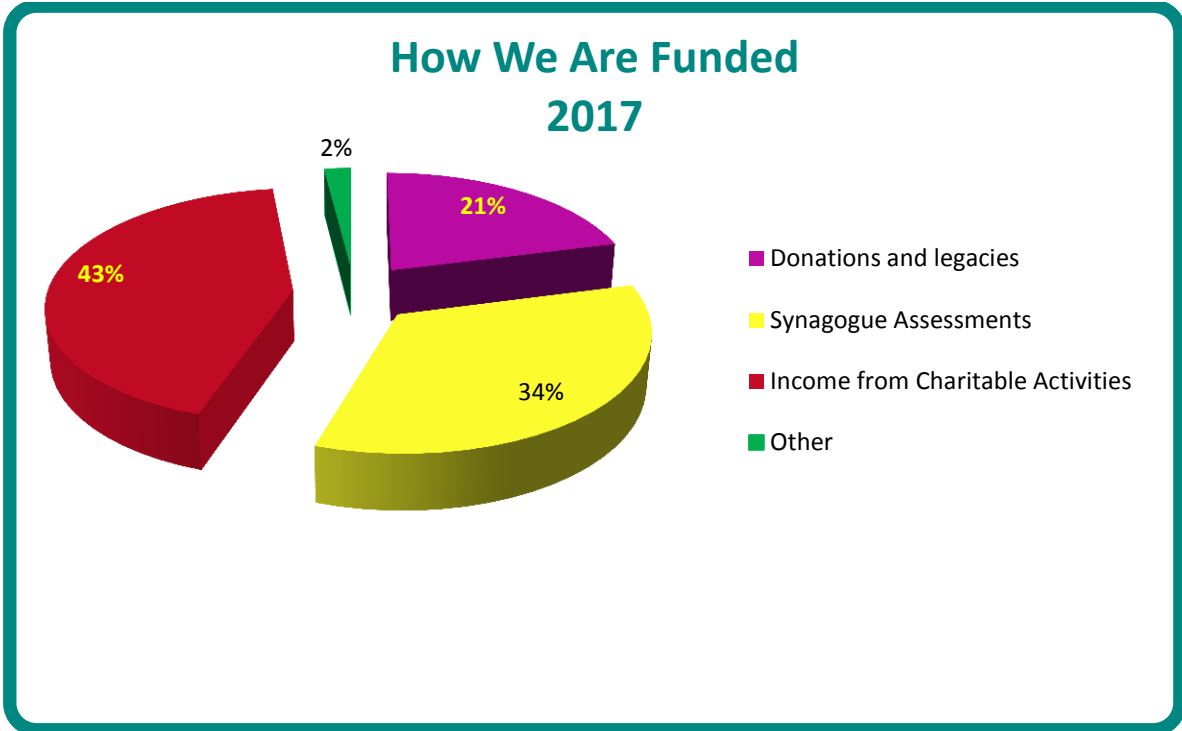

# **Independent Auditors' Report**

## **To The Trustees of**

### **The Movement for Reform Judaism**

#### **Opinion**

We have audited the financial statements of The Movement for Reform Judaism for the year ended 31 December 2017, which comprise the Statement of Financial Activities, the Statement of Financial Position, the Statement of Cash Flows, and the related notes, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice).

This report is made solely to the charitable company's members, as a body, in accordance with Chapter 3 of Part 16 of the Companies Act 2006. Our audit work has been undertaken so that we might state to the charitable company's members those matters we are required to state to them in an Auditors' Report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the charitable company and the charitable company's members, as a body, for our audit work, for this report, or for the opinions we have formed.

In our opinion the financial statements:

- Give a true and fair view of the state of the charitable company's affairs as at 31 December 2017 and of its surplus for the year then ended;
- Have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- Have been prepared in accordance with the requirements of the Companies Act 2006.

#### **Basis for opinion**

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the Auditors' responsibilities for the audit of the financial statements section of our report. We are independent of the charitable company in accordance with the ethical requirements that are relevant to our audit of the financial statements in the United Kingdom, including the Financial Reporting Council's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

## **Independent Auditors' Report To The Trustees of The Movement for Reform Judaism (contd)**

### **Conclusions relating to going concern**

We have nothing to report in respect of the following matters in relation to which the ISAs (UK) require us to report to you where:

- The trustees' use of the going concern basis of accounting in the preparation of the financial statements is not appropriate; or
- The trustees have not disclosed in the financial statements any identified material uncertainties that may cast significant doubt about the charitable company's ability to continue to adopt the going concern basis of accounting for a period of at least twelve months from the date when the financial statements are authorised for issue.

### **Other information**

The trustees are responsible for the other information. The other information comprises the information included in the Annual Report, other than the financial statements and our Auditors' Report thereon. Our opinion on the financial statements does not cover the information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

### **Opinion on other matters prescribed by the Companies Act 2006**

In our opinion, based on the work undertaken in the course of the audit:

- The information given in the Trustees' Report for the financial year for which the financial statements are prepared is consistent with the financial statements; and
- The Trustees' Report has been prepared in accordance with applicable legal requirements.

## **Independent Auditors' Report To The Trustees of The Movement for Reform Judaism (contd)**

### **Matters on which we are required to report by exception**

In the light of the knowledge and understanding of the charitable company and its environment obtained in the course of the audit, we have not identified material misstatements in the Trustee's Report.

We have nothing to report in respect of the following matters in relation to which the Companies Act 2006 requires us to report to you if, in our opinion:

- Adequate accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us; or
- The financial statements are not in agreement with the accounting records and returns; or
- Certain disclosures of trustees' remuneration specified by law are not made; or
- We have not received all the information and explanations we require for our audit; or

The trustees were not entitled to prepare the financial statements in accordance with the small companies' regime and take advantage of the small companies' exemptions in preparing the Trustees' Report.

### **Responsibilities of trustees**

### 1. Accounting Policies and Details of Estimates

#### 1.1 Statement of compliance

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006

The Movement for Reform Judaism meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

#### 1.2 Company information

The Movement for Reform Judaism is a private company limited by guarantee and incorporated in England. The address of its registered office and principal place of business is The Sternberg Centre for Judaism, 80 East End Road, London, N3 2SY.

#### 1.3 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

Transfer between funds occur for a number of reasons including when funds are closed on completion of a project, when fixed assets are purchased or when Trustees decide to release funds from a designated fund.

#### 1.4 Income

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Income arises from grants and donations, fundraising events, Israel tours and other activities and events. Income from donations and legacies is recognised on an actual receipts basis. Income from Investments is recognised on an actual receipts basis. Income from Charitable Activities for synagogue levy is recognised on an actual receipts basis and income for Events and Tours is recognised on a most probable basis.

#### 1.5 Expenditure

Expenditure is charged to the Statement of Financial Activities on an accruals basis as a liability is incurred and is classified as follows:

- i. Cost of Raising Funds – this comprises all costs incurred with attracting voluntary income to finance the charitable objectives.
- ii. Charitable Expenditure – this comprises all expenditure incurred in the delivery of activities and services.
- iii. Support Costs – this comprises central costs which are allocated to the charitable activities and governance costs on a basis consistent with the use of the resources.
- iv. Governance Costs – this comprises all costs associated with meeting constitutional and statutory requirements.

#### 1.6 **Going concern**

The Trustees have reviewed the circumstances of the charity, and consider that adequate resources continue to be available to fund the activities of the charity of the foreseeable future. The Trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern.

#### 1.7 **Tangible fixed assets and depreciation**

##### *Building development*

Improvements are for the charity's share of a major site development project that was completed in 2012. The improvements are stated at cost less accumulated depreciation.

##### *Furniture and equipment*

Furniture and equipment are stated at cost less accumulated depreciation and any accumulated impairment losses. Cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

##### *Depreciation and residual values*

Tangible assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

##### *Tangible fixed assets*

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Furniture and equipment	-	20% reducing balance

#### 1.8 **Stocks**

Stock is valued at the lower of cost and net realisable value on a first in first out basis.

#### 1.9 **Debtors**

Trade and other debtors are recognised at the settlement amount after any trade discount offered. Prepayments are valued at the amount repaid net of any trade discounts due.

#### 1.10 **Cash at bank and in hand**

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

#### 1.11 **Creditors**

Creditors are normally recognised at their settlement amount after allowing for any trade discounts due.

#### 1.12 **Judgements in applying accounting policies and key sources of estimation uncertainty**

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported for assets and liabilities as at the reporting date and the amounts reported for revenues and expenses during the year. However, the nature of estimation means that actual outcomes could differ from those estimates.

##### *Accruals*

The company makes an estimate of accruals at the year-end based on invoices received after the year end and work undertaken which has not been invoiced based on quotations or estimates of amounts that may be due for payment.

#### *Tangible assets*

Tangible assets are depreciated over their useful lives taking into account residual values where appropriate. The actual lives of the assets and residual values are assessed annually and may vary depending upon a number of factors. In re-assessing the assets' lives, factors such as technological innovation, product life cycles and maintenance programmes are taken into account.

#### 1.13 **Provisions for liabilities**

Provisions are made where an event has taken place that gives the charity a legal or constructive obligation that probably requires settlement by a transfer of economic benefit, and a reliable estimate can be made of the amount of the obligation.

Provisions are charged as an expense to statement of financial activities in the year that the charity becomes aware of the obligation, and are measured at the best estimate at the reporting date of the expenditure required to settle the obligation, taking into account relevant risks and uncertainties.

Contingent liabilities are not recognised. They arise as a result of past events when (i) it is not probable that there will be an outflow of resources or that the amount cannot be reliably measured at the reporting date, or (ii) when the existence will be confirmed by the occurrence or non-occurrence of uncertain future events not wholly within the charity's control. Contingent liabilities are disclosed in the financial statements unless the probability of an outflow is remote.

When payments are eventually made, they are charged to the provision carried in statement of financial position.
