COMMUNITY AT THE CROSS ROADS.

A stranger attending the Friday night and Sabbath morning services in Bristol might well ask "Is there a Jewish Community in this City?" That a Community exists was evident by the large crowd who so enthusiastically attended a recent social function in the Synagogue Hall. What is not realised is that without the Synagogue its offices and its services the Community would cease to exist. Equally, without the attendance of the Community, the Synagogue would cease to exist. So a vicious Circle is set up to whichever way the wheel turns, it means the disappearance of the Jewish Community.

How many of our readers realise that this state of affairs practically exists already? Quite apart from the fact that social and charitable activities are invariably in the hands of the same hardworking few, the Synagogue attendances are now appalling. On Friday December 20th for the evening service there were present six persons including Mr. Lotner. The following day, nine members It is worthy of note that this was at a holiday weekend when many members normally prevented from attending Synagogue services for "economic" reasons, were not at But, this shocking state of affairs is nothing new, A Minyan on Friday evening is a rarity and now the Sabbath morning Minyan has become a matter for conjecture. This is not a case of religious conviction only, it is a case of struggle for survival. How can we bring home to our children the beauty and the obligation of Synagogue worship, if they see only empty seats, or spend a fruitless hour on Sabbath morning waiting for a Minyan. I feel that I feel that there are many who could attend on Friday evening, if the will was only there. There is no sin in coming straight from work to join in what I always consider to be one of the loveliest services in the liturgy. There are many, I am certain, who could spare the time to attend on Saturday morning. Maybe, as I have said, they have not got the religious conviction, but surely they would not wish to see the Bristol Jewish Community disappear.

We have heard much about the need for spiritual leadership and guidance, but those who have such ideas have short memories. There is no need for guidance. Let each one search his own heart. Let every man and woman say "What am I going to do for the survival of this Community?" There can only be one answer.
