THE JEWISH BLIND SOCIETY

SUNDAY, OCTOBER 23RD - AT THE SYNAGOGUE HALL

As Chairman of the Jewish Blind Society, I very much appreciate the facilities that have been granted to me to address members of the Bristol Congregation on the work of the Jewish Blind Society.

The extent of blindness amongst Jewish people is not generally appreciated and is estimated to be one in every three hundred who are registered as blind or partially sighted.

The Jewish Blind Society operates in every town and city, and its welfare officers make it their task to be in touch with every Jewish blind person. In our residential homes and welfare centres we care for some 1,500 blind persons.

The object of the exercise is to create in Bristol an Aid Society to interest themselves in our work. By these means we become more closely associated with the city of Bristol and will be enabled to seek out people who suffer from this disability, and our welfare officers will be more closely in touch with people who need their help.

Although we do know of blind people in both Bristol and Wiltshire whom we are concerned with today, we feel sure that there might be others needing our help.

It is not intended to make any appeal for funds at this gathering, but to create a Society of those ready to assist when they learn of our problems.

I do hope you will find it possible to attend the gathering with members of your family, at 7.30 p.m. on Sunday, October 23rd, at the Synagogue Hall, and become conversant with our work.
