The following account was written by Naum Meiman, a Moscow-refusenik who first applied for an exit visa in 1974. The former Professor of Mathematica has been constantly refused an exit visa on grounds of "secrecy", though his work has been published.

DNE DAY IN THE LIFE OF A REFUSENIK

by Dr. Naum Meiman

The day - it was December 24th - ended well as they released me in the evening. The whole story was quite common-place, but it is worth describing as it was really so very typical.

At seven-thirty in the morning, the local militia man, a captain, appeared at my apartment accompanied by someone in civilian clothes. They demanded that I should come together with them to the office for a "conversation with the superiors".

It is difficult to imagine what are the rights of the local militia man. Had he the right to demand — without an order — that he should be allowed to enter the apartment, that I should show him my documents and accompany him to the office? It is also unclear where one would go to find out about the rights of the local militia man.

However, it is hardly pleasant to be held under seigs in one's own apartment. I therefore agreed to come there at nine and the two men left. I learned later that they waited for me at the entrance to the house.

At the office I was met by a young man, who after my refusal to speak with him unless he identified himself, at last introduced himself as the Inspector of the Investigation Department, Yevgeny Ivanovich Ovsyankin. After a short conversation they left me in the office, alone, and locked it. I had no choice but to sit and wait.

At five in the efternoon, efter eight hours of being held under lock and key, they turned my arrest into a house arrest and I had the chance of eating and getting some rest. Two hours later I was brought back to the office where I was met by a rather respectable locking man in civilian clothes. The man showed me the cover of some identification card and then I asked him his name and position. He said, "Just call me Nikolay Alekseevich".

When I refused to speak to this Mikolay Alexkseevich he answered, "I'll tell you my family name and then they'll tell on the radio, on all kinds of 'Voices' about our conversation.

He added that his superiors (whose names he did not mention), gave him special instructions that I should refrain from passing on information about our conversation.

I answered that I could not give such a promise and furthermore, it was possible that while I was being detained, a report had already been made on the radio. He then warmed me that if I did not change my attitude, the Criminal Code could be used against me. He did not offer any violations, or administrative regulation, but nevertheless threatened to put me on trial.

Now absurd! Someone who did not state his surname or position, was threatening me in the name of his unnamed superiors with a trial for a crime he did not specify. Contrary to an anonymous warning that one could teer up without reading, such a warning bould not be avoided as they keep you locked up a whole day.

I don't think the day December 24th was accidental. It is the day of the Prisoners of Conscience, which is usually marked by a silent demonstration near the Lenin Library. Many of my friends were also detained that day. It is obvious the violations of human rights are clear to all, except for those who do not want to understand.

"Where's the washing powder please? Tony (Quentin) replied innocently. By the policeman's expression he was beginning to think this was not a launderette. After all where were the washing machines?

"I think, sir, that you have come into the wrong place. This is a police station". At this Tony (Quentin) began to perspire, his hands shook nervously. Then, with a swift movement, totally lacking in grace, he retrieved his .4567389201 \(\frac{1}{4} \) from his pocket and shot the first policeman in his forehead, letting loose the red insides. The policeman squinted and pleaded for his last rights. Tony (Quentin) feeling sympathetic towards the other two uniforms, raised his death-piece and made them accompany their friend on his long journey to the head of the 'Beth Din', G-D. As the dying men lay slumped across the desk in front of them, they uttered some grateful appreciation.

"Oh thanks so much, sir. When I can I'll put your name forward for an O.B.E."
"That's alright, anytime. I'll do it again if you wish it" He said honestly.
"No, there's no need for anymore" the two men replied hastily. Then Tony (Quentin) cleared up the BLOODY mess and bought some cigarettes from a nearby machine.

Coming from the police station Tony (Quentiu) ran along the High Street and entered his mother's house. Instinctively he ran up the stairs and into his bedroom and collected some articles in a vacant suitcase. Downstairs his mother, pleased to see her son, whom she had not seen for 6 years, was detectibly annoyed. "Where do you think you've been, then?. For 6 years I haven't even seen you. Then you just rush in, up to your old bedroom to collect your old clothes, and you don't even say Hello!!!! Where have you been? What have you done with yourself? Where are you living? ARE you living? Actually it's a good thing you've come home, as there are some shelves that need putting up. They're in the garage and......."
Tony (Quentin) scampered downstairs, ignoring his mother, and left the house through the garden. "Aron't you staying for dinner? And what about the shelves?????
And don't you say goodhye!!!! I suppose now that your a sorter at Grunwick you don't say goodbye any more. Wait until your father hears about this, because you'll get a real good thrusbing!!!!!! When I was a little girl, if I was told to do..."

Meanwhile, as his mother bawled on for another 6 years, Tony (Quentin) was on the 3 o'clock train to Dusfermline, to attend the annual conference on "how to combat nepotism".
