

After almost two years of fundraising and planning the building work for Abraham's Tent, our project is now complete. SLLS's disused caretaker's flat has now been converted and refurbished to accommodate a refugee family at present living in a refugee camp.



The family who arrive in 2019 will be supported by a community sponsorship partnership (a collaboration between Liberal Judaism, West London Synagogue and SLLS).

Once they arrive, volunteers will advocate for the family to access the services they need, support their acquisition of the English language and befriend and mentor them. co-ordinated with several local groups including the Hyderi Islamic Centre and three local churches to develop our plan to support a family in the synagogue building by means of community sponsorship.

Abraham's Tent Project Harriet Neuberger

During 2017/2018 Abraham's Tent Project grew from a dream and fundraising target to a project very much made up of bricks and mortar. Our disused one-bedroom caretaker's flat, with ripped out kitchen and bathroom and peeling wood chip walls, has been transformed over the year. Guided by designs by James and Félicie Krikler, who redesigned the space into a warm two bed with open plan kitchen diner, we invited various builders to the property to offer quotes. We were fortunate to receive a congregant's recommendation for builder Ronnie Baba from Eliteskill, whom we appointed in January. They worked with us on all the infrastructure problems of getting safe gas and electricity to the property. After a community-wide effort to clear the flat of all the items accumulated there (Gesher books, old council minutes and dumped furniture) the building work started in May. By the end of July all structural and infrastructure work had been done, the flooring was being laid and only the kitchen and bathroom remained to be completed.

While the physical need for a haven for a refugee family is clear, Abraham's Tent Project was about providing more than a house to the family - welcoming them into the midst of our community. Hence, in partnership with Lambeth Refugees Welcome, we hosted a summer party at the beginning of July. Over a hundred people attended from the families that have already settled in Lambeth, and the Lily Montagu Hall was full of food, fun, music and games. The party was a great success, and launched our Community Sponsorship partnership bid with West London Synagogue and Liberal Judaism to support the family once they arrive as community volunteers. This partnership had grown in strength over the year and is currently in negotiation with the Home Office formally to take responsibility for resettling the family once they arrive.

What has been amazing is the sense of community that has been established through this project, with other members of the Jewish community, our neighbouring places of worship and the wider community showing their support. Over this year we have raised nearly £50,000 from over 200 distinct donors including donors from every faith and none, our closest neighbours and international donors. We look forward to 2018/2019 when the flat will be completed, furnished and we shall finally be able to welcome a refugee household into its own self-contained apartment, in what was formerly a part of our synagogue.

Lambeth Commemoration for Holocaust Memorial Day 2018

For a tenth year we were actively involved in planning the Lambeth HMD commemoration in January.

School visits

An important aspect of our interfaith work is our schools programme; pupils visiting us at SLLS and, on occasion, our visits to local schools. We hosted a number of schools this past year with groups ranging from 25 to 90 pupils at a time and covering school grades Year 1 to Year 7.

Chaplaincy and Caring

Board of Deputies of British Jews Jeromé Freedman

1st June 2018 saw the beginning of the Board's latest triennial session since its foundation in 1760. The newly elected president is Marie Van der Zyl, only the second woman to be so elected. In addition, two more women were elected amongst the new vice-presidents who are Sheila Gewolb, senior vice-president; Amanda Bowman and Edwin Shuker. The Board's treasurer, Stuart MacDonald, a deputy for Liberal Judaism, was re-elected unopposed.

A new report, "Synagogue Membership in the UK in 2016" was produced by the Institute for Jewish Policy Research (JPR) on behalf of the Board of Deputies and reveals that 79,597 Jewish households across the UK held synagogue membership in 2016, down from 99,763 in 1990 being a 20% decline over a quarter of a century. The authors maintain that this is only partly due to assimilation and can be explained by demographic forces – a general decline in the number of UK Jewish households.

This report, that is certainly worthy of further study, shows that whilst the numbers of the Liberal and Reform memberships are largely stable representing, at 27%, about one third of the UK Jewish households, the mainstream Orthodox numbers have dropped from 66% in 1990 to 53% in 2016 though they remain the largest denominational group. In comparison, the strictly Orthodox group has grown by 139% since 1990 being 13.5%, and up from 4.5% a generation ago.

Concluding on a personal note, I have served as a deputy continuously for 21 years, the first six for Liberal Judaism whilst I was chairman, and subsequently for SLLS, and was re-elected in January for a further three years. The congregation is entitled to appoint, at no cost, a "Designated Observer" who is aged under 35. This position is still vacant. I should be more than happy to introduce any such member if he/she would like to contact me.

Citizens UK Lianna Etkind

SLLS continues to be involved in the Lambeth branch of campaigning alliance Citizens UK. Seven members of the synagogue attended the Delegate's Assembly in October 2017, joining local churches, schools and charities to set the key campaign agenda for the 2018 local elections. Four of our members also attended the Accountability Assembly at King's College London in April 2018, in which candidates standing for positions on the council were encouraged to make pledges on key issues prior to the election. SLLS has since been involved in post-election meetings, following up with Lib Peck, Leader of Lambeth Council, on candidate's pledges on affordable housing, access to university and supporting refugees.

As part of the Abraham's Tent project, SLLS also maintains a relationship with Lambeth Refugees Welcome, a project group of Lambeth Citizens. Through this link, synagogue members have

5778 feels like a year when a number of things bubbling away have started to come into fruition. We saw the then Student Rabbi Nathan fill the shul for his first High Holy Days with us. He finished the year as a fully ordained rabbi and I was delighted that around 20 of us from South London went to his ordination service at the Liberal Jewish Synagogue back in July. And, most importantly, we managed to convince him to stay with us, starting as our full time rabbi in 5779.

A second highlight of the year was the fact that we started the building works to renovate the flat that we will make available to a Syrian refugee family. By the end of the summer, the flat was looking little like its previous incarnation as Gesher classrooms. I know Harriet is producing a separate report on this, but she is unlikely to acknowledge how much of her spare time she has given to making this project happen - a very big thank you to her.

I'll finish my report by saying a big thank you to everyone for helping to keep our community up and running. From those of you who do very visible things like providing kiddush, running Gesher (a very big thank you to Jackie) and to those who do so much behind the scenes - in particular Louise and Lou. Finally, no community would function without a wonderful rabbi so I want to thank Rabbi Nathan for all he has done for us over the past two years as a student rabbi and I look forward to seeing the community go from strength to strength under his spiritual leadership.

Minister's Report Rabbi Nathan Godleman

I am pleased to find myself in the position of writing my second annual report at SLLS. A little different this time, of course, as I do so as rabbi, rather than student minister, having been ordained on 2 July 2018. As well as a personal transition, it is one shared with the synagogue, which now has a full-time rabbi; its first for some years. Suffice it to say, I am honoured to be that person and it is very encouraging that this could be achieved. I thank all those involved.

I will speak broadly for the remainder of this report, constrained in specifics to the period ending on the day before my official tenure began, i.e. 31 August. For two years, following the retirement of my predecessor, a student rabbi served as minister, ably supported by a group of lay leaders and lay readers, who deserve to be applauded for their contribution, on and off the bimah. My time was divided between the Leo Baeck College, where I was completing my rabbinic studies, SLLS and other work commitments. I think that it is remarkable how much we achieved, nevertheless.

Often, the most important things in life are the most difficult to quantify. Alongside a general upturn in attendances and stable numbers, in terms of membership, the atmosphere has been wholly positive, I feel. The building, especially when Gesher is sitting, is a happy, noisy, vibrant place to be, and it signals a bright future. Old members are returning, others are getting more involved and new people are coming, liking what they see, and staying. Challenges include how to harness this energy to specific tasks. In other words, attracting more volunteers to relieve and replace those in our current pool. The AGM and the end of the Gesher year will see some key people stepping down and others needing to take on the mantle. Each member has a responsibility, not only to help run things, but to support new initiatives simply by being there.

In the past, I have written and spoken of having reached a turning point. I now feel we have moved beyond that, with a vista of bright, sunlit uplands, even! SLLS is most definitely on the map: in terms of the wider movement, where we take our place as a pillar of Liberal Judaism; in terms of the wider community, with the Abraham's Tent project coming to fruition and continuing to attract nationwide attention; and, crucially, in the lives of our members and friends, whose pastoral, educational, life-cycle and worship needs continue to be met at South London Liberal Synagogue, and where Judaism, in its communal aspect, is playing an ever-greater part in their lives. May it continue to do so and may the work of our hands prosper.

The year in review

We welcomed a number of new members during the course of the year and we welcomed three young people who celebrated Kabbalat Torah – Lori Bennison, Rachel Feuer and Arthur Krikler.

We had birthday kiddushim and Eitz Chavim leaf dedications.

Our Garden Shabbatot continued to be popular but although the summer weather was mainly sunny and cloudless the Shabbat evening weather did not always allow services to be held outside.

Once again we were involved with our neighbours in arranging the annual Lambeth HMD Commemoration. Since the Lambeth Assembly Hall was still undergoing refurbishment we were grateful to the Surrey County Cricket Club for once more hosting the event at the Kia Oval. The theme for the year was "The Power of Words". The keynote speaker was Nikos Souslouos, an HMDT Youth Champion Board Member, with contributions from Refugees Welcome, Dunraven School and the choir from Corpus Christi School. We have continued to be active within Lambeth Citizens (see separate report).

In Jewish Studies our Israel term culminated in an Israel themed day where we created a mosaic to recognise the 100th anniversary of the Balfour Declaration. The World Union for Progressive Judaism's over 1,200 congregations around the world – both large and small, some established and others just starting – currently affiliate with Reform. Progressive, Liberal or Reconstructionist Judaism. With an estimated 1.8 million members in 45 countries, the liberal streams of Judaism represent a global community with diverse practices but a similar goal: a contemporary, creative expression of Jewish spiritual and cultural identity that is rooted in our rich Jewish traditions.

The European Union of the World Union, based in London, focuses particularly on the challenges of continental Europe where the increasing Jewish population now provides enormous potential for growth. A well organized European Union Beit Din provides a coherent structure for emerging communities and offers a modus vivendi for individuals and for new groups living under difficult circumstances particularly in former Communist countries. www.eupj.org/

The Council presents its report together with the Financial Statements of the Synagogue for the year ended 31 August 2018. These Financial Statements are not statutorily required to be audited and have been independently examined by Una Ní Dhónaill whose report appears below.

Origin, objectives and principal aims and activities of the charity

The Synagogue was formed in 1929 and has the following purpose:

to advance Liberal Judaism by actions, teaching and practice, in particular (but not exclusively) by

2. Tangible Fixed Assets and Depreciation
